



# STALLION SERVICE CONTRACT

I hereby agree on \_\_\_\_\_ day of \_\_\_\_\_, to breed the mare \_\_\_\_\_, Reg No. \_\_\_\_\_, to the stallion Mr Boomerjac AQHA Reg No 3472432 for the 2010 season. The stallion fee is \$2000 which includes a NON-REFUNDABLE booking fee of \$500 which shall be payable upon execution of the contract.

The balance of the Stallion Fee plus all unpaid expenses will be payable upon receipt of an invoice or before the mare leaves the farm, whichever is first. The breeder requires 48 hours advance notice when the mare owner wishes to remove his mare (s) from the farm. The mare (and foal, if applicable) shall be released only upon payment in full of any outstanding invoices, including those from the attending veterinarian.

The mare shall be in healthy and sound breeding condition, free from infection, contagious or transmissible disease. A current negative Coggins test, photostat copy of registration papers (both sides), plus a health, worming and immunization record must accompany the mare. If they do not, stallion manager's veterinarian will examine and/or test mare at mare owner's expense. Stallion manager reserves the right to refuse the mare if not in satisfactory condition or does not have records and documents as listed above.

Stallion manager will exercise judgment in care and supervision of mare and/or foal. Stallion manager's veterinarian will examine mare for normal breeding conditions and will administer care as deemed necessary for the health and safety of the mare and/or foal. Mare owner hereby consents to all medical care administered by stallion manager's veterinarian.

Stallion manager agrees to diligently try to settle owner's mare. Mare owner agrees to give stallion manager ample opportunity to settle mare. Mike McEntire Reining Horses Inc does not give a Live Foal Guarantee for any mare leaving the farm unless the mare has been pregnancy checked and found to be in foam by the farm veterinarian. IF THE MARE LEAVES THEN ALL UNPAID BOARD, EXPENSES AND BREEDING FEE BECOME DUE AND PAYABLE and the live foal guarantee then becomes void. If, however, for any reason the mare does not settle, mare owner will hold stallion management harmless. The above applies through normal breeding season, February 15<sup>th</sup> through July 15<sup>th</sup>.

A LIVE FOAL guarantee is contained within this contract and a live foal is described as a newborn foal which stands and nurses without assistance. Should a live foal not be produced from this breeding then a re-breed will be honored for the following year with a re-breed fee of \$500. If the breeding is donated then a \$500 chute fee applies to the re-breed. Rebreed privileges shall apply only if Mike McEntire Reining Horses Inc is notified within 7 days thereof and receives a veterinarian's statement confirming death. If mare dies or becomes unfit for breeding the mare owner may return the following year 2011 with an approved substitute mare. The live foal guarantee is non-transferable.

A breeder's certificate will be issued upon notification of the birth of the foal and after any outstanding fees and expenses have been paid in full.

The parties further agree that should the stallion die or become unfit for breeding purposes, this contract shall become null and void and any money paid on the stallion fee, except the non-refundable booking fee shall be refunded to the mare owner.

Both parties agree that the breeding farm, the stallion manager, its owners, employees and guests shall not be liable for any injury, sickness, disease, accident or death of any horse on its premises. The above mare owner, whose horse (s) is (are) under the care of Mike McEntire Reining Horses Inc will not be liable for any damage, injury or death to the breeding farm stallion, employees, veterinarian or any other animals in the care of the farm, whether or not caused by his horse.

This contract represents the entire agreement between the parties. No other agreements, verbal or implied, are included unless specifically stated in this written contract.

This contract is entered into in the state of North Carolina and shall be governed by the laws of this state. It represents the agreement between the parties. When the mare owner/lessee signs and returns this contract, it will be a binding contract on both parties subject to the above terms and conditions.
