



# COOLED SEMEN CONTRACT

I hereby agree on \_\_\_\_\_ day of \_\_\_\_\_, to breed the mare \_\_\_\_\_, Reg No. \_\_\_\_\_, to the stallion Mr Boomerjac AQHA Reg No 3472432 for the 2012 season. The stallion fee is \$2000 which includes a NON-REFUNDABLE booking fee of \$500 which shall be payable upon execution of the contract. The balance of the Stallion Fee plus shipping fee must be paid no later than 10 days prior to the first semen shipment.

There will be a minimum charge of \$300 for each shipment of cooled semen sent out which must be paid for prior to shipping. There will be an extra charge of \$75 for any counter to counter shipment. The equitainer must be returned at the mare owner's expense within 4 working days using express or other traceable delivery service. There will be a \$50/day penalty for any container not returned within 4 days.

It is highly recommended to send the mare to a specialized breeding facility under the supervision of qualified vets and technicians. Mare owner must provide name and address of premises where semen will be shipped. Mare owner or veterinarian must request semen by 4pm prior to the shipping day and cancellation must be made by 9am (EST) on day of shipment.

McEntire breeding farm agrees to provide semen on an available basis from 02/15 to 07/15. Please call for stallion collection schedule and mares being bred on the premises will have breeding priority on any breeding day. Mike McEntire Reining Horses makes no guarantee of delivery within a certain time period and makes no guarantee that the cooled semen will safely reach the insemination point without losing integrity, quality or characteristics. Mike McEntire Reining Horses will be held harmless if the mare fails to settle for any reason.

A LIVE FOAL guarantee is contained within this contract and a live foal is described as a newborn foal which stands and nurses without assistance. Should a live foal not be produced from this breeding then a re-breed will be honored for the following year with a re-breed fee of \$500. Rebreed privileges shall apply only if Mike McEntire Reining Horses is notified within 7 days thereof and receives a veterinarian's statement confirming death. If mare dies or becomes unfit for breeding the mare owner may return the following year 2013 with an approved substitute mare. The live foal guarantee is non-transferable.

A breeder's certificate will be issued upon notification of the birth of the foal and after any outstanding fees and expenses have been paid in full.

The parties further agree that should the stallion die or become unfit for breeding purposes, this contract shall become null and void and any money paid on the stallion fee, except the non-refundable booking fee shall be refunded to the mare owner.

This contract is entered into on the state of North Carolina and shall be governed by the laws of this state. It represents the agreement between the parties. When the mare owner/lessee signs and returns this contract, it will be a binding contract on both parties subject to the above terms and conditions.
